AGREEMENT BETWEEN

THE ALABAMA DEPARTMENT OF SENIOR SERVICES

AND

(JEFFERSON COUNTY, ALABAMA) THE OFFICE OF SENIOR CITIZENS SERVICES(OSCS)

This agreement is by and between the Alabama Department of Senior Services (ADSS) and (Jefferson County, Alabama) The Office of Senior Citizens Services (contractor) regarding the provision of Medicaid home and community based services to Medicaid-eligible persons as administered by the Alabama Medicaid Agency.

WHEREAS, the Alabama Department of Senior Services and the Alabama Medicaid Agency, two agencies of the State of Alabama, have entered into an agreement to assure needed services for certain Medicaid-eligible persons requiring care; and

WHEREAS, ADSS and the contractor desire to enter into an agreement for the provision of these services in the contractor's service area;

NOW, THEREFORE, in consideration of the above premises and the mutual promises contained herein, ADS S and the contractor, intending to be mutually bound agree as follows:

- 1. ADSS hereby designates the contractor as its agent to be responsible for assessment evaluation and reassessments to be conducted by appropriate professionals as specified in the Waiver. Medical eligibility determinations and re-determinations will be certified by a qualified health professional and a physician licensed to practice in Alabama. Contractor shall be responsible for arranging Waiver services and ADSS
- and contractor are both responsible for ongoing monitoring of Waiver services provided to Waiver clients. All such evaluations are subject to ADSS review and approval at any time.
- 2. The contractor will hold ADSS harmless as to any penalties incurred by reason of any noncompliance arising out of or connected with services eligibility therefore as contemplated by this agreement. Contractor will fully indemnify and reimburse ADS S for any penalties, disallowances, or other recoupment of funds from Medicaid by the federal government resulting from any condition of noncompliance which is due to any erroneous or insufficient action, or inaction by contractor. Contractor further agrees to reimburse the state share of any additional Home and Community Based Services (HCBS) expenses incurred for ADSS clients, including staff time and other costs of adjusting claims, resulting from such action or inaction, when the additional expense is incurred by Medicaid due to necessary corrective actions in response to an actual or potential federal recoupment due to fraudulent or negligent actions by the contractor or its subcontractors. Contractor acknowledges that Medicaid is responsible for monitoring all services rendered pursuant to said Waiver including audits of both program services and financial costs. Contractor further acknowledges that Medicaid may conduct audits of subcontractors and will notify subcontractors directly of its findings and that Medicaid will further provide said subcontractors the opportunity to directly request any applicable administrative procedure including a fair hearing should any action be taken which requires same.
- 3. The total compensation to the contractor shall not exceed the lesser of; actual allowable expenditures incurred by the contractor or the total amount of the approved budget, whichever is less. Cost incurred by the contractor shall be in accordance with 45 CFR Part 95 and the Office of Management and Budget Circular A-87 (OMB Circular A-87) as well as Alabama Medicaid Administrative Code Rule Number 560 X-36-.07.
- 4. The contractor shall prepare and submit a budget in accordance with ADSS procedures. The approved budget shall be the basis for the financial operation of programs described in this agreement. Amounts budgeted for each major category, administration and services, shall be subject to a maximum flexibility of $\pm 10\%$ but in no event exceed the total amount of the approved budget. Budget changes in excess of $\pm 10\%$ for a major category or which increases/decreases the total budget amount requires a budget revision approved by ADSS.
- 5. Medicaid shall make no payment for services rendered in violation of this agreement. Payments made for services rendered in violation of this agreement may be recovered through appropriate administrative and/or legal action.
- 6. Under no circumstances shall the commitment under this agreement constitute a debt of the State of Abama as prohibited by Section 213, Constitution of Alabama 1901, Amendment XXVI. It is further agreed that if any provision of this agreement shall contravene any statute or Constitutional provision or amendment, whether now in effect or which may, during the course of this agreement, be enacted, then that conflicting provision in the agreement shall be deemed null and void. The contractor's sole remedy for the settlement of any and all disputes arising under the terms of this agreement will be limited to the filing of a claim against ADSS with the Board of Adjustments for the State of Alabama.
- 7. The parties shall comply with Titles VI and VII of the Civil Rights Act of 1964, the Federal Age Discrimination Act, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990.
- 8. ADSS and the contractor agree to implement and maintain such services and procedures as may be necessary for the proper and orderly administration of the Waivered services program, including keeping of all appropriate records (financial and otherwise), so as to ensure the continuation of the program in accordance with the Alabama State Medicaid Plan, as authorized and limited by said Waiver, and within guidelines and regulations established or to be established by ADSS, by the AMA and by the DHHS now applicable or later made applicable to this program. The parties further agree to the division of responsibilities set out in the approved Waiver and agree to faithfully perform assigned duties on the financial basis set out herein. Said Waiver and the Medicaid Policy and Procedures Manual are adopted by reference as part of this agreement. Additional policies and interpretations related to the Waiver will be effective sixty (60) days from the date of receipt by ADSS of written instruction.

- 9. The contractor shall submit a written "Quarterly Cost Report" and any other reports requested in accordance with ADSS procedures. The contractor shall supply ADSS such information as shall be required by the Department of Health and Human Services (DHHS), the Alabama Medicaid Agency (AMA), and ADSS on the impact of the Waiver in accordance with a data collection plan designed by the Secretary of DHHS.
- 10. The terms of this agreement shall apply only to persons who require Elderly and Disabled Waiver services in the community, who are categorically eligible as identified in the Waiver, and who are served by ADSS.
- 11. The contractor agrees to provide those services as specified in the Waiver to all approved recipients in the type and amount as indicated on the physician-approved care plan. Contractor may subcontract for services necessary to the completion and maintenance of this agreement and to the performance of its duties under this agreement. All subcontracts must be in writing, with the subcontractors' functions and duties clearly identified, and must require the subcontractors to comply with all applicable provisions of this agreement. Contractor at all times remains responsible for performance by subcontractors. ADSS shall not release contractor from any claims or defaults of this agreement when such claims or defaults are predicated upon any action or inaction or default by any subcontractor of contractor.
- 12. The contractor shall maintain financial records, supporting documents, statistical records, and all other records pertinent to the Waiver for a period of five (5) years from the date of the last payment made by ADSS to the contractor. However, if audit, litigation, or other legal action by or on behalf of the State or Federal Government has begun but is not completed at the end of the five-year period, or if audit findings, litigation, or other legal action has not been resolved at the end of the five-year period, the records shall be retained until resolution.
- 13. The contractor agrees that representatives of the Comptroller General, the Department of Health and Human Services, the General Accounting Office, the Alabama Department of Examiners of Public Accounts, the Alabama Medicaid Agency, ADSS, or their designee shall have the right to inspect and copy the contractor's books and records pertaining to the extent and cost of services furnished to eligible recipients. The contractor shall cooperate fully with requests from any of the agencies listed above and shall furnish free of charge copies of all requested records. The contractor may require that a receipt be given for any original record removed from its premises.
- 14. This agreement is valid through September 30, 2016. Upon mutual consent of all parties, this agreement may be extended by written amendment. This agreement may be cancelled by either party at any time upon written notice to the other party giving at least thirty (30) days notice prior to any proposed termination date. This agreement may be amended upon mutual agreement of both parties.

The parties hereto expressly agree that their responsibilities to one another shall be contingent upon availability of federal and state funds as specified in the approved Waiver and that such responsibilities shall terminate if said funds cease to be available upon notice by Medicaid to contractor and contractor will be entitled to reimbursement for services provided prior to termination upon submission of a certified, itemized invoice that details the work performed prior to the termination.

- 16. In the event of proration of the funds from which payment under this agreement is to be made, this agreement will be subject to termination.
- 17. All parties shall comply with the provisions of the Health Insurance Portability and Accountability Act (HIPAA) and any implementing regulations as adopted.
- 18. Pursuant to Ala.Code §31-13-9(k), by signing this agreement, the parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom. Failure to comply with these requirements may result in termination of the agreement or subcontract.

HOME AND COMMUNITY-BASED SERVICES FOR THE HIV/AIDS WAIVER AGREEMENT BETWEEN ALABAMA DEPARTMENT OF SENIOR SERVICES

AND

(JEFFERSON COUNTY, ALABAMA) OFFICE OF SENIOR CITIZENS SERVICES

This agreement is by and between the Alabama Department of Senior Services, hereinafter referred to as "ADSS" and (Jefferson County, Alabama) the Office of Senior Citizens Services, hereinafter referred to as "contractor" regarding the provision of Medicaid reimbursement for Medicaid-eligible persons who receive home and community-based services in accordance with the Department of Health and Human Services (DHHS) - approved Title XIX of the Social Security Act Waiver for HIV/AIDS (No. 0382), hereinafter referred to as "Waiver".

WHEREAS, the Alabama Department of Senior Services and the Alabama Medicaid Agency, two agencies of the State of Alabama, have entered into an agreement to assure needed services for certain Medicaid-eligible persons requiring care; and

WHEREAS, ADSS and contractor desire to enter into an agreement for the provision of these services in the contractor's service area; NOW, THEREFORE, in consideration of the above premises and the mutual promises contained herein, ADSS and contractor, intending to be mutually bound and agree as follows:

- 1. ADSS hereby designates contractor as its agent to be responsible for the activities specified in the approved HIV/AIDS Waiver document in the provision of HIV/AIDS Waiver services.
- 2. ADSS hereby designates contractor as its agent to be responsible for admission, evaluation, and re-evaluation of the client's appropriateness for the Waiver by using appropriate professionals as specified in the approved Waiver. Contractor shall be responsible for arranging and the ongoing monitoring of Waiver services provided to Waiver clients. All such evaluations are subject to ADSS review and approval at any time.
- 3. The contractor will hold ADSS harmless as to any penalties incurred by reason of any noncompliance arising out of or connected with services eligibility therefore as contemplated by this agreement.
- 4. The contractor shall submit a written "Quarterly Cost Report" and any other reports requested in accordance with the ADSS procedures. The contractor shall supply the ADSS such information as shall be required by the Department of Health and Human Services (DHHS), the Alabama Medicaid Agency (AMA), and the ADSS on the impact of the Waiver in accordance with a data collection plan designed by the Secretary of DHHS.
- 5. Contractor will fully indemnify and reimburse ADSS for any penalties, dis-allowances, or other recoupments of funds from Medicaid by the federal government resulting from any condition of noncompliance which is due to any erroneous or insufficient action, or inaction by contractor. Contractor further agrees to reimburse the state share of any additional Home and Community-Based Services (HCBS) expense incurred for ADSS clients, including staff time and other costs of adjusting claims, resulting from such action or inaction, when the additional expense is incurred by Medicaid due to necessary corrective actions in response to an actual or potential federal recoupment due to fraudulent or negligent actions or inactions by contractor or its subcontractors. Medicaid is responsible for monitoring all services rendered pursuant to said Waiver including audits of both program services and financial costs. Medicaid may conduct audits of subcontractors and will notify ADSS directly of its findings. Medicaid will further provide ADS S the opportunity to directly request any applicable administrative procedure including a fair hearing should any action be taken which requires same.
- 6. The contractor shall prepare and submit a budget in accordance with the ADSS's procedures. The approved budget shall be the basis for the financial operation of programs described in this agreement. Amounts budgeted for each major category, administration and services, shall be subject to a maximum flexibility of +/-10% for a major category or which increases/decreases the total budget amount requires a budget revision approved by the ADS S.
- 7. The total compensation to the contractor shall not exceed the lesser of; actual allowable expenditures incurred by the contractor or the total amount of the approved budget, whichever is less. Cost incurred by the contractor shall be in accordance with 45 CFR Part 95 and the Office of Management and Budget Circular A-87 (OMB Circular A-87).
- 8. The ADSS and the contractor agree to implement and maintain such services and procedures as may be necessary to the proper and orderly administration of the waivered services program, including keeping of all appropriate records (financial and otherwise), so as to ensure the continuation of the program in accordance with the Alabama State Medicaid Plan, as authorized and limited by said Waiver, and within guidelines and regulations established or to be established by the ADS S, by the AMA and by the DHHS now applicable or later made applicable to this program. The parties further agree to the division of responsibilities set out in the approved Waiver and agree to faithfully perform assigned duties on the financial basis set out herein. Said Waiver is adopted by reference as a part of this agreement.
- 9. The terms of this agreement shall apply only to persons who require HIV/AIDS Waiver services in the community, who are

categorically eligible as identified in the Waiver, and who are served by the ADSS.

- 10. The contractor shall maintain financial records, supporting documents, statistical records, and all other records pertinent to the Waiver for a period of five (5) years from the date of the last payment made by the ADSS to the contractor. However, if audit, litigation, or other legal action by or on behalf of the State or Federal Government has begun but is not completed at the end of the five-year period, or if audit findings, litigation, or other legal action has not been resolved at the end of the five-year period, the records shall be retained until resolution.
- 11. The contractor agrees that representatives of the Comptroller General, the Department of Health and Human Services, the General Accounting Office, the Alabama Department of Examiners of Public Accounts, the Alabama Medicaid Agency, the Alabama Department of Senior Services, or their designee shall have the right to inspect and copy the contractor's books and records pertaining to the extent and cost of services furnished to eligible recipients. -The contractor shall cooperate fully with requests from any of the agencies listed above and shall furnish free of charge copies of all r9quested records. The contractor may require that a receipt be given for any original record removed from its premises.
- 12. Each officer or employee of any person to whom Social Security information is or may be disclosed shall be notified in writing by such person that Social Security information disclosed to such officer or employee can be only used for authorized purposes and to that extent and any other unauthorized use herein constitutes a felony punishable upon conviction by a fine of as much as \$5,000 or imprisonment for as long as five years, or both, together with the cost of prosecution. Such person shall also notify each such officer or employee that any such unauthorized further disclosure of Social Security information may also result in an award of civil damages against the officer or employee in an amount not less than \$1,000 with respect to each instance of unauthorized disclosure.

These penalties are prescribed by IRC Sections 7213 and 7431 and set forth at 26 CFR 301.6103(n).

Additionally, it is incumbent upon contractor to inform its officers and employees of penalties for improper disclosure implied by the Privacy Act of 1974, 5 U. S.C. 552a. Specifically, 5 USC 552a (i) (1), which is made applicable to contractors by 5 U.S.C. 552a(m)(1), provides that any officer or employee of a contractor, who by virtue of his/her employment or official position, has possession of or access to agency records which contain individually identifiable information, the disclosure of which is prohibited by the Privacy Act or regulations established thereunder, and who knowing that disclosure of the specific material is prohibited, willfully discloses that material in any manner to any person or agency not entitled to receive it, shall be guilty of a misdemeanor and fined not more than \$5,000.

- 13. The parties hereto expressly agree that their responsibilities to one another shall be contingent upon availability of federal and state funds as specified in the approved Waiver and that such responsibilities shall terminate if said funds cease to be available. In the event of proration of all the funds from which payment under this contract is to be made, this contract will be subject to termination.
- 14. The term of this agreement ends September 30, 2016 provided, contractor acknowledges and understands that this contract is not effective until ADSS has received all requisite state government approvals and contractor shall not begin performing work under this contract until notified to do so by ADSS. Contractor is entitled to no compensation for work performed prior to the effective date of this contract. This agreement may be renewed by agreement of all parties for subsequent approved Waiver periods subject to the extension of the Waiver by DHHS. This agreement may be canceled by either party at any time upon written notice to the other party giving at least thirty (30) days' notice prior to any proposed termination date. This contract maybe amended upon mutual agreement in writing of both parties.
- 15. Under no circumstances shall the commitments under this contract constitute a debt of the State of Alabama as prohibited by Section 213, Constitution of Alabama (1901), Amendment XXVI. It is further agreed that if any provision of this contract shall contravene any statute or constitutional provision or amendment, whether now in effect or which may, during the course of this contract, be enacted, then that conflicting provision in the contract shall be deemed null and void. The contractor's sole remedy for the settlement of any and all disputes arising under the terms of this agreement shall be limited to the filing of a claim with the Board of Adjustment for the State of Alabama.
- 16. Pursuant to Ala. Code §31-13-9(k), by signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.
- 17. Contractor shall comply with all provisions of the attached Business Associate Addendum. (See attachment A)
- 18. All parties shall comply with the provisions of the Health Insurance Portability and Accountability Act (HIPAA) and any implementing

regulations as adopted.

19. The parties shall comply with Titles VI and VII of the Civil Rights Act of 1964, the Federal Age Discrimination Act, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990.

Failure to comply with these requirements may result in termination of the agreement or subcontract.
