

# NOTICE OF PARTIAL REFUNDING

## JEFFERSON COUNTY, ALABAMA SEWER REVENUE CAPITAL IMPROVEMENT WARRANTS SERIES 1999-A DATED MARCH 1, 1999

**NOTICE IS HEREBY GIVEN** that Jefferson County, Alabama (the "County") has deposited cash and obligations issued or guaranteed by the United States into an irrevocable Escrow Fund in order to redeem on February 1, 2009 a portion of the County's outstanding Sewer Revenue Capital Improvement Warrants, Series 1999-A (the "Series 1999-A Warrants") and to pay the interest, when due, on such warrants until such redemption date. The Series 1999-A Warrants so refunded (hereafter referred to as the "Refunded Warrants") include \$147,650,000 of the \$281,240,000 outstanding Series 1999-A Warrants due February 1, 2033, to be selected by lot, and all of the \$120,735,000 and \$104,935,000 outstanding Series 1999-A Warrants due February 1, 2029 and February 1, 2039 respectively. All the Refunded Warrants will be called for redemption at a price equal to 101% of their principal amount plus accrued interest to the redemption date.

In order to distinguish the Refunded Warrants that mature on February 1, 2033 from the unrefunded portion of the Series 1999-A Warrants of such maturity, new CUSIP numbers have been assigned to those of such Refunded Warrants as well as such unrefunded warrants. The new CUSIP numbers and other information are outlined below.

Please note that all Series 1999-A Warrants maturing on February 1, 2033, whether selected for refunding or not, must be returned to the Paying Agent/Registrar (at the address listed below) to be exchanged for new Series 1999-A Warrants. New CUSIP Numbers will be assigned to each indicating whether such Series 1999-A Warrant has been refunded or has not been refunded. No transfer forms, bond powers or other forms need to be presented to the Paying Agent/Registrar for reissuance.

All Series 1999-A Warrants maturing on February 1, 2033 should be delivered either in person or by certified/registered mail to be exchanged for new Series 1999-A Warrants to the following address:
