## NOTICE OF PARTIAL REFUNDING

## JEFFERSON COUNTY, ALABAMA SEWER REVENUE REFUNDING WARRANTS SERIES 1997-A DATED FEBRUARY 1, 1997

**NOTICE IS HEREBY GIVEN** that Jefferson County, Alabama (the "County") has deposited cash and obligations issued or guaranteed by the United States into an irrevocable Escrow Fund in order to redeem on February 1, 2007, a portion of the County's outstanding Sewer Revenue Refunding Warrants, Series 1997-A (the "Series 1997-A Warrants"), and to pay the interest, when due, on such warrants until such redemption date. The Series 1997-A Warrants so refunded (hereafter referred to as the "Refunded Warrants") include \$29,855,000 of the \$41,640,000 outstanding Series 1997-A Warrants due February 1, 2022 to be selected by lot and \$98,915,000 of the \$137,965,000 outstanding Series 1997-A Warrants due February 1, 2027 to be selected by lot. Refunded Warrants due February 1, 2022 will be called for redemption at a price equal to 101% of their principal amount plus accrued interest to the redemption date. Refunded Warrants due February 1, 2027 will be called for redemption at a price equal to 100% of their principal amount plus accrued interest to the redemption date

In order to distinguish the Refunded Warrants of each maturity from the unrefunded portion of the Series 1997-A Warrants of such maturity, new CUSIP numbers have been assigned to those of such Refunded Warrants as well such unrefunded warrants. The new CUSIP numbers and other information are outlined below.
