THIS AGREEMENT entered into this 2<sup>nd</sup> day of August, 2010, by and between Jefferson County, Alabama, hereinafter called "the County", and Molton, Allen & Williams, LLC located at 1000 Urban Center Drive, Suite 400, Birmingham, AL 35243 hereinafter called "the Contractor". The effective date of this agreement shall be September 1, 2010.

WHEREAS, the County desires to contract for broker of record services for the Human Resources Department, hereinafter called "Human Resources", and

WHEREAS, the Contractor desires to furnish said services to the County.

NOW, THEREFORE, the parties hereto do mutually agree as follows:

1. ENGAGEMENT OF CONTRACTOR: The County hereto agrees to engage the Contractor and the Contractor hereby agrees to perform the services hereinafter set forth.

2. SCOPE OF SERVICES: This Contract results from Jefferson County's Request for Qualifications No. 108-10 dated April14, 2010, the terms of which are included herein by reference. The Contractor shall provide insurance Broker of Record Services to include the solicitation and placement of insurance in the best interests of Jefferson County Commission. The Contractor shall review and evaluate the County's exposure to risk; prepare annual marketing strategy reports identifying anticipated market conditions and proposing a marketing strategy for the County's major loss exposure areas prior to policy renewal; assist in developing underwriting data and specifications for renewal negotiations; provide trended values for property insurance policies; with participation of the Director of Human Resources or her designee, obtain bids from the insurance industry and negotiate the best terms and coverage for the various exposure areas and submit information to the director of Human Resources for approval by the Commission; evaluate the commitment and financial stability of the underwriters; service existing insurance policies by tendering losses, reviewing coverage issues, assisting in collection of losses, reporting values, issuing Certificates of Insurance as needed, processing policy changes, etc., in a timely manner, schedule quarterly meetings with the Director of Human Resources or her designee, to discuss loss control issues, exposure changes, and general administrative matters; provide monthly cost reports for excess health, vision and dental claims including fixed costs, gross premiums and paid claims, pooling charges and Incurred But Not Reported (IBNR) reserve; with participation of the Human Resources Director or her designee, obtain initial premium renewals and negotiate for the lowest renewal rates seek and analyze premium rates with comparable benefits providers, giving preference to the local markets if they are in the best interest of the County; provide updates on excess health, dental and vision insurance markets, legislative issues and cost trends; provide assistance in developing strategy for cost containment and annual renewals; analyze the County's exposure to loss, adequacy of coverage, and develop options on coverage not presently purchased by the County; provide service for day-today contact on insurance matters; assist the County in developing insurance requirements for the various contracts (design, construction, and services) and in reviewing insurance policies, contracts, leases, and bonds as requested by the County; prepare an annual report including a schedule of policies in force, coverage provisions, premiums, insurance claims experience for the prior policy year and recommendations for possible adjustments to insurance coverage for the next policy year (the report should provide a summary of broker support services rendered during the prior year, with recommendations for broker services recommended for the subsequent year; provide other services that

are normally and customarily required of an insurance broker for County government. Insurances shall include but are not limited to excess worker's compensation, property & casualty, boiler & machinery, crime & dishonesty, excess health, basic life insurance, basic accidental death & dismemberment, voluntary life, voluntary accidental death & dismemberment, dental and vision, and bonds.

3. TERMS OF AGREEMENT AND AUTHORIZATION TO PERFORM WORK: The term of the contract is for one year (1) September 1, 2010 through August 31, 2011. However, the Contract maybe extended, at the County's option, for two (2) additional oneyear periods, not to exceed three full years.

4. COMPENSATION: The Contractor shall be compensated for services to the County per the brokerage fees received from insurance companies selected to provide insurance benefits and coverage for the County. In the event of a subcontract, Molton, Allen & Williams, LLC must maintain a continuous effective business relationship with the subcontractors) including, but not limited to, regular payment of all monies owed to any subcontractor. Failure to comply with these requirements, in whole or part, will result in termination of the contract and/or legal ramifications, due to nonperformance

6. GOVERNING LAW/DISPUTE RESOLUTION: The parties agree that this contract is made and entered into in Jefferson County, Alabama and that all services, materials and equipment to be rendered pursuant to said Agreement are to be delivered in Jefferson County, Alabama. The interpretation and enforcement of this Agreement will be governed by the laws of the State of Alabama. The parties agree that jurisdiction and venue over all disputes arising under this Agreement shall be the Circuit Court of Jefferson County Alabama, Birmingham Division

7. STATEMENT OF CONFIDENTIALITY: Contractor agrees that any information accessed or gained in performance of those duties will be maintained in absolute confidence and will not be released, discussed, or made known to any party or parties for any reason whatsoever, except as required in the conduct of duties required, or where disclosure is required by law or mandated by a court of law.

8. INDEPENDENT CONTRACTOR: The Contractor acknowledges and understands that the performance of this contract is as an independent contractor and as such, the Contractor is obligated for Workmen's Compensation, FICA taxes, Occupational Taxes, all applicable federal, state and local taxes, etc. and that the County will not be obligated for same under this contract.

9. NONDISCRIMINATION POLICY: The Jefferson County Commission is strongly committed to equal opportunity in solicitation of ITB's and RFP's. The County encourages bidders and proposers to share this commitment. Each bidder submitting a proposal agrees not to refuse to hire, discharge, promote, demote, or to otherwise discriminate against any person otherwise qualified solely because of race, creed, sex, national origin or disability.

10. MISCELLANEOUS REQUIREMENTS: Upon execution of this contract, the Contractor shall furnish the Jefferson County Finance Department with information required for Form 1099 reporting and other pertinent data required by law.

11. TERMINATION OF CONTRACT: This contract may be terminated by the County with a thirty (30) day written notice to the other party regardless of reason. Any violation of this agreement shall constitute a breach and default of this agreement. Upon such breach, the County shall have the right to immediately terminate the contract and withhold further payments. Such termination shall not relieve the Contractor of any liability to the County for damages sustained by virtue of a breach by the Contractor.

12. LIABILITY:

A. The Contractor shall not, without prior written permission of the COUNTY specifically authorizing them to do so, represent or hold themselves out to others as an agent of or act on behalf of the COUNTY.

B. The Contractor will indemnify and save harmless the COUNTY, its elected officials and its employees from claims, suit, action, damage and cost of every name and description resulting from the performance of the Contractor, its agents, subcontractors or employees under this Contract COUNTY agrees, to the extent allowed by law, to indemnify and save harmless the Contractor, its corporate officers and its employees from claims, suit, action, damage and cost of every name and description resulting from the performance of services to the COUNTY its agents, subcontractor or employees under this contract.

AMENDMENT OF AGREEMENT: This Contract contains the entire understanding of the parties, and no change of any term or provision of the Contract shall be valid or binding unless so amended by written instrument which has been executed or approved by the County. Any such amendment shall be attached to and made a part of this Contract. A written request must be made to the County and an amended agreement will be executed.

15. INSURANCE: Contractor will maintain such insurance as will protect him and the County from claims under Workmen's

Compensation Acts and from claims for damage and/or personal injury, including death, which may arise from operations under this contract. Insurance will be written by companies authorized to do business in Jefferson County, Alabama. 16. HOLD HARMLESS AND INDEMNIFICATION: Contracting party agrees to indemnify, hold harmless and defend Jefferson County, Alabama, its elected officers and employees (hereinafter referred to in this paragraph collectively as "County"), from and against any and all loss expense or damage, including court cost and attorney's fees, for liability claimed against or imposed upon County because of bodily injury, death or property damage, real or personal, including loss of use thereof arising out of or as a consequence of the breach of any duty or obligations of the contracting party included in this agreement, negligent acts, errors or omissions, including engineering and/or professional error, fault, mistake or negligence of Contractor, its employees, agents, representatives, or subcontractors, their employees, agents or representatives in connections with or incident to the performance of this agreement, or arising out of Worker's Compensation claims, Unemployment Compensation claims, or Unemployment Disability compensation claims of employees of company and/or its subcontractors or claims under similar such laws or obligations. The grant funds will be used to continue to render services to strengthen the capability to provide all Medicare eligible individuals information, counseling, assistance and to ensure a network of staff and volunteers to provide accurate and objective heath insurance information and assistance. This grant period is from April 1, 2010 - March 31, 2011.

Agreement for Services for the Alabama State Health Insurance Assistance Program (SHIP)

### Grant Period: April 1, 2010 - March 31, 2011

This agreement is entered into this 1<sup>st</sup> day of April 2010, by and between the Office of Senior Citizens Services (hereinafter referred to as the grantee) and the Alabama Department of Senior Services for the local implementation of the State Health Insurance Assistance Program (SHIP) grant. The grantee will be part of Alabama's effort to strengthen its capability to provide all Medicare eligible individuals information, counseling and assistance on health insurance matters.

#### TERM OF GRANT

The grant shall terminate not later than March 31, 2011 or anytime prior if funds for this grant are no longer available, or other conditions or circumstances should cause this grant to be altered, modified, extended or terminated.

### PERFORMANCE REQUIREMENTS

The State Health Insurance Assistance Program (SHIP) grant is intended to strengthen the capability of States to provide all Medicare eligible individuals information, counseling, and assistance on health insurance matters. The grant from the Centers for Medicare & Medicaid Services (CMS) helps ensure that States have a network of staff and volunteers to provide accurate and objective health insurance information and assistance in making informed health coverage decisions and understanding related rights and protections. Although States have adopted a variety of methods to provide such services to individuals, Section 4360 of the Omnibus Budget Reconciliation Act of 1990 requires that each State program must encompass particular activities:

Objective 1 Grantee will provide personalized counseling to an increasing number and diversity of individual beneficiaries unable to access other channels of information or needing and preferring locally-based individual counseling services.

Objective 2 Grantee will conduct targeted community outreach to beneficiaries in public forums either under their sponsorship or with community-based partners or coalitions to increase understanding of Medicare program benefits and raise awareness of the opportunities for assistance with benefit and plan selection.

Objective 3 Grantee will increase and enhance beneficiary access to a counselor work force that is trained, certified, and fully equipped and proficient in providing the full range of services including enrollment assistance in appropriate benefit plans, and continued enrollment assistance in prescription drug coverage.

Objective 4 Grantee will participate in CMS education and communication activities, as required by ADSS, to assure that SHIP counselors are equipped to respond to both Medicare program updates and a rapidly changing counseling environment and to provide CMS with information about the support and resources that SHIPS need to provide accurate and reliable counseling services. The grantee shall:

1. Provide counseling and assistance to eligible individuals in need of health insurance information including:

a. Information that may assist individuals in obtaining benefits and filing claims under Titles XVIII and XIX of the Social Security Act.

b. Policy comparison information for Medicare supplemental policies (as described in section 1882(g)(1) of the Social Security Act, as amended) and information that may assist eligible individuals with filing claims under such Medicare supplemental policies.

c. Information regarding long-term care insurance.

- d. Information regarding Medicaid programs, including Medicare Savings Programs.
- e. Information regarding other types of health insurance benefits that may be provided to eligible individuals in the State.

f. Information regarding health insurance coverage options created under the Balanced Budget Act of 1997 and subsequent amendments under the Balanced Budget Refinement Act of 1999, the Benefits Improvement and Protection Act of 2000, and the Medicare Prescription Drug, Improvement and Modernization Act (DIMA) of 2003.

2. Conduct outreach programs to provide health insurance information, counseling and assistance to eligible individuals, including an emphasis on reaching vulnerable, isolated and non-English speaking seniors, and those under 65 who are disabled. In achieving these efforts, the grantee shall:

a. Provide counseling to a greater number of individual beneficiaries unable to access other channels of information or needing and preferring locally-based individual counseling services.

b. Create more counseling resources and locations that are locally accessible to low-income, dual eligible, and hard-to-reach beneficiaries, including rural communities.

c. Increase targeted outreach in order to provide access to counseling to low-income, dual-eligible, and hard-to-reach populations.

d. Provide educational materials as necessary to assist in achieving these standards.

3. Develop systems of referral to appropriate Federal or State departments or agencies that provide assistance with problems related to health insurance coverage (including legal problems).

4. Assure full accessibility of SHIP services to all categories of Medicare eligible individuals, including the aged, disabled, and end stage renal disease patients. SHIP services are to be provided without discrimination on the basis of race, color, national origin, disability, age, sex, or income. Reasonable efforts must also be made to accommodate eligible individuals with existing barriers that limit their access to information, e.g. language, visual, hearing or speech impairments, physical accessibility, literacy, and location.

5. Establish a sufficient number of staff positions (including volunteers) necessary to provide the services of a health insurance information, counseling and assistance program.

6. Request, as necessary, federal Unique Identifiers for staff and volunteers through state SHIP office. Maintain copies of signed confidentiality agreements for individually assigned Unique IDs.

7. Assure that SHIP staff and volunteers have no conflict of interest in providing health insurance information, counseling and assistance, and agree to abide by the SHIP Security Plan and confidentiality agreements for safeguarding confidential beneficiary information.

8. Collect and disseminate timely and accurate health insurance information to staff members (including volunteers).

9. Utilize state and federal training program materials as part of the training program for staff members (including volunteers). Conduct a certification review to ensure volunteers and staff are trained in accordance with their job duties. Conduct continuing education to ensure volunteers and staff are up to date in the knowledge necessary to complete their duties.

10. Recruit and screen the volunteer and staff workforce for the program. As such, the grantee shall:

a. Provide formal training opportunities for SHIP coordinators and volunteers utilizing state and federal training materials, including the preparation of copies of materials.

b. Ensure completion of the volunteer application form and confidentiality/non-conflict of interest form for all volunteers.

c. Ensure that all volunteers who provide one-to-one counseling and education seminars have satisfactorily completed extended training and volunteers of all other job descriptions have satisfactorily completed basic training.

d. Ensure that all volunteers have satisfactorily completed their certification review upon the completion of training.

e. Implement quality assurance protocols within the program.

f. Provide up-to-date resources, information, and training libraries (either in paper or electronic) to local volunteers.

g. Create and support full local volunteer access to Internet-based information, training materials, counseling and enrollment tools as necessary.

h. Train volunteers on the use of Internet-based counseling, SHIP program tools, and Internet-based enrollment tools.

i. Solicit direct feed-back from counselors to determine if the training and support materials they receive are helpful in counseling activities.

j. Ensure that any notices from state or federal resources are delivered and explained to counselors in a timely manner.

11. Terminate any volunteer from SHIP who has failed to meet the agreed commitments of the program, including but not limited to:

a. Failure to meet the terms of the confidentiality/non-conflict of interest

b. Failure to attend more than 2 consecutive update training.

c. Consistent poor feedback from quality assurance mechanisms

12. Ensure that SHIP services are publicized to Medicare beneficiaries throughout the program area. Maintain contact with the community, including distributing literature and speaking at public gatherings to promote SHIP. Make available and distribute promotional SHIP supplies and materials to increase awareness of SHIP services.

13. Sponsor at least one recognition event annually for SHIP volunteers at a minimal cost.

- 14. Increase SHIP participation in CMS education activities. The grantee shall:
  - a. Ensure SHIP coordinator access to training materials through registration on www.shiptalk.org.
  - b. Ensure that the SHIP coordinator posts events and activities on the AAA and/or ADSS website.
  - c. Ensure contact information for the grantee on www.shiptalk.org is accurate and current.

# PROGRAM REQUIREMENTS

1. Respond to constituent requests for information and/or assistance in a timely fashion (the standard is within two (2) business days).

2. The grantee shall make available to ADSS copies of all publications, intake forms, training materials, systems, items developed and samples of any forms used by the grantee to provide these services. The grantee agrees that ADSS and the Centers for Medicare and Medicaid Services (CMS) shall have royalty-free, non exclusive and irrevocable rights to reproduce, publish or otherwise use, and authorize others to use the items for state or federal purposes.

3. All SHIP materials published by the grantee shall include the acknowledgment that "This publication has been created or produced by the Alabama SHIP with financial assistance, in whole or in part, through a grant from the Centers for Medicare and Medicaid Services, the Federal Medicare agency." The grantee is also expected to use the Alabama SHIP logo on all SHIP publications.

4. Ensure program/agency representation at SHIP coordinator meetings/trainings/conference calls.

5. Achieve a minimum of 70 percent of all performance measures established for the grantee as outlined in Exhibit I.

6. The grantee shall establish the capability to send and receive email and to access and download internet published information in the provision of SHIP services.

7. ADSS will monitor and assess programmatic records, reports and activities under this Agreement and the attached workplan to determine the effectiveness and efficiency of service delivery. ADSS and CMS or the appropriate designee shall have ready access to all reports and records relating to this agreement, subject to the maintenance of client confidentiality required by all governing entities.

#### NOTIFICATION REQUIREMENTS

1. The grantee is required to notify the State SHIP Director of any changes in key personnel, contact information, or other significant administrative changes immediately upon learning of the change. This includes, but is not limited to, changes to permissions for Unique IDs issued.

### **REPORTING REQUIREMENTS**

The grantee shall:

1. Enter the following into SHIPMATES on a monthly basis and no later than the 10<sup>th</sup> day of the month following the end of the calendar month of service to which they apply:

- a. Data for all Client Contacts
- b. Data for all Public and Media Activities
- c. Data for the Resource Report

2. Provide the SHIP Director information regarding upcoming events on a monthly basis and no later than the 10<sup>th</sup> day of the month prior to the event.

3. Complete required information for a midterm narrative report as required by CMS. The report shall include both a description of the progress made toward meeting each of the four objectives and objectives related to the performance measures as outlined in Exhibit I. The midterm progress report will cover the period from date of grant award through August 31, 2010. The report itself will be due on September 10, 2011.

4. The grantee will assume responsibility for the accuracy and completeness of the information contained in all documents and reports.

5. The data reported monthly must have supportive documentation for verification purposes. Documentation shall be retained for a period of three years as set forth and described in 45 C.F.R. Section 92.42. Copies or other facsimiles of program records, such as electronic media, are acceptable substitutions for original documents.

6. Financial reports shall be required in accordance with ADSS policies and procedures.

### AMENDMENTS

No alteration or variation of the terms of the grant shall be valid unless made in writing and duly signed by the parties thereto. The grant may be amended by written agreement duly executed by the parties or in the event of program changes by the Centers for Medicare and Medicaid Services. Any such amendment shall specify the date its provisions shall be effective as agreed to by the parties. CONFIDENTIALITY

Grantee shall treat all information, and in particular information relating to individuals that is obtained by or through its performance

under the contract, as confidential information to the extent confidential treatment is provided under State and Federal laws and regulations. Grantee shall not use any information so obtained in any manner except as necessary for the proper discharge of its obligations and rights under this grant agreement.

# TERMINATION

- 1. Upon a material breach by Grantee, ADSS shall immediately terminate this grant.
- 2. Either party to this grant may terminate this grant upon provision of thirty (30) days prior written notice.

# GRANTEE STATUS

The grantee is not an agent or employee of the State or ADSS.

# DISPUTES

For any and all disputes arising under the terms of this grant, the parties hereto agree, in compliance with the recommendations of the Governor and Attorney General, when considering settlement of such disputes, to utilize appropriate forms of nonbinding alternative dispute resolution including, but not limited to, mediation by and through the Attorney General's Office of Administrative Hearings or where appropriate, private mediators.

### **INDEMNIFICATION**

Grantee shall be liable and agrees to be liable for and shall indemnify, defend, and hold ADSS and the State and its officers, employees

and agents harmless from all claims, suits, judgments or damages, including court costs and attorney fees, arising out of or in connection with this grant due to negligent, erroneous or intentional acts or omissions of the grantee and/or any sub-grantees/contractors. Grantee shall hold the State harmless from all sub-grantees/contractors' liabilities under the terms of this contract.

### NOT TO CONSTITUTE A DEBT OF THE STATE

Under no circumstances shall any commitments by ADSS constitute a debt of the State of Alabama as prohibited by Article XI, Section 213, Constitution of Alabama of 1901, as amended by Amendment 26. It is further agreed that if any provision of this grant shall contravene any statute or Constitutional provision or amendment, whether now in effect or which may, during the course of this grant, be enacted, then that conflicting provision in the grant shall be deemed null and void. The Grantee's sole remedy for the settlement of any and all disputes arising under the terms of this agreement shall be limited to the filing of a claim against ADSS with the Board of Adjustment for the State of Alabama.

#### AUDITS AND INSPECTIONS

At any time during normal business hours, and as often as ADSS may deem necessary for purposes of monitoring and evaluation, the grantee shall make available to ADSS, the Alabama Department of Examiners of Public Accounts, the Comptroller General or any other authorized designee all records with respect to matters covered by this grant agreement and will permit ADSS or those authorized designees to audit, examine, investigate, or extract excerpts from invoices, materials, documents, papers, records or other data relating to matters covered by the grant.

### PAYMENT

Grantee shall submit to ADSS a detailed invoice for compensation for the deliverable and/or work performed. Administrative or indirect costs shall not exceed ten (10) percent of the total grant award without prior written approval of ADSS. Invoices should be submitted to the ADSS Finance Department according to ADSS policies and procedures. Payments are dependent upon timely and successful completion and acceptance of described work and delivery of required documentation.

### NONDISCRIMINATORY COMPLIANCE

Grantee shall comply with Title VII of the Civil Rights Act of 1964 and 1991, the Age Discrimination in Employment Act of 1975, the Rehabilitation Act of 1973, the Americans with Disabilities Act of 1990, and all other applicable federal and state laws, rules and regulations with respect to nondiscrimination in employment and/or sub-grants.

#### CONTRACT ASSURANCES

### CONTRACT FOR PROFESSIONAL SERVICES

THIS AGREEMENT entered into this 1<sup>st</sup> day of July 2010 by and between Jefferson County, Alabama, hereinafter called "the County", and, Jefferson County Council on Aging, hereinafter called "the Contractor". The effective date of this agreement shall be July 1, 2010.

WHEREAS, the County desires to contract for professional services for the Office of Senior Citizens Services, hereinafter called "the

Office", and

WHEREAS, the Contractor desires to furnish said professional services to the County;

NOW, THEREFORE, the parties hereto do mutually agree as follows:

1. EMPLOYMENT OF CONTRACTOR: The County hereto agrees to engage the Contractor and the Contractor hereby agrees to perform the services hereinafter set forth.

2. SCOPE OF SERVICES: The Contractor shall perform all necessary professional services under this Contract as required by the Office. The Contractor shall do, perform, and carry out in a satisfactory and proper professional manner the Senior Service America, Inc. as described in the Program Component (Attachment II) of this Contract.

### ATTACHMENT II

#### PROGRAM COMPONENT

#### Title V

#### Alabama Dept. of Senior Services

The Alabama Department of Senior Service is a program of the Jefferson County Office of Senior Citizens Services under the supervision of the Jefferson County Commission. It is funded seventy-five percent (75%) by a Title V grant from the Alabama Department of Senior Services with twenty-five percent (25%) local matching funds. The Jefferson County Office of Senior Citizens Services maintains total control and supervisory responsibilities for the Alabama Department of Senior Services.

The Agency, the Jefferson County Council on Aging, shall provide fiscal administration of the Title V funds to pay salaries, FICA and Workman's Compensation Insurance for the approximately thirty-seven (37) older individuals employed by the Alabama Department of Senior Services, Inc. Supportive Services available to Senior Workers including training, physical examination or incidental expenditures shall also be paid using Title V funds.

The administrative funds of Title V should be used for the purpose of reimbursement to ADP for services rendered and for any cost related to payroll. These funds may be used to pay for a percentage of the audit cost for the Agency as outlined in the budget. All expenditures made from the administrative funds must be approved in advance by the Executive Director of the Jefferson County Office of Senior Citizens Services. Exhibit II found in Contract #239-A shall be submitted monthly to the County along with the SA-1. Supporting documentation of expenses paid from administrative funds shall be made available to the County as requested. (All other attachments/exhibits not included with agreement)

3. TERMS OF AGREEMENT AND AUTHORIZATION TO PERFORM WORK: The Contractor shall be available to render professional services to the Office at any time after the effective date of this Contract. This contract will be effective July 1, 2010 and will terminate on June 30, 2011. However, contract may be extended, at the County's option. Provided, also, that the County may cancel upon 30 days written notice to the Contractor.

4. COMPENSATION: The Contractor shall be compensated for services as shown on Attachment I of this Contract. The total for the contract to June 30, 2010 is \$382,461.00 of which \$344,215.00 is federal funding with \$38,246.00 being non-federal. The Contractor shall submit to the Office monthly Report (Exhibit I) for completion for work performed. The Contractor shall submit a monthly (SA-1) Report of Expenditures Request for Funds (Exhibit I) unless other arrangements are made with the Office's Accounting Department.

5. INDEPENDENT CONTRACTOR: The Contractor acknowledges and understands that the performance of this contract is as an independent contractor and as such, the Contractor is obligated for all applicable federal, state and local taxes, etc. except for FICA taxes and Worker's Compensation which is part of the budget component shown on Attachment 1.

6. NONDISCRIMINATION POLICY: Both parties agree that all services rendered under this contract will be done without regard to race, creed, color, sex, national origin, or disability.

7. MISCELLANEOUS REQUIREMENTS: Upon execution of this contract, the Contractor shall furnish the Jefferson County Finance Department with information required for Form 1099 reporting and other pertinent data required by law.

8. TERMINATION OF CONTRACT: This contract may be terminated by the County with a thirty (30) day written notice to the other party regardless of reason. Any violation of this agreement shall constitute a breach and default of this agreement. 1. EMPLOYMENT OF CONTRACTOR: The County hereto agrees to engage the Contractor and the Contractor hereby agrees to

perform the services hereinafter set forth.

2. SCOPE OF SERVICES: The Contractor shall perform all necessary professional services under this Contract as required by the Office.

The Contractor shall do, perform, and carry out in a satisfactory and proper professional manner the Senior Service America, Inc. as described in the Program Component (Attachment II) of this Contract.

### ATTACHMENT II

#### PROGRAM COMPONENT

Title V

#### Senior Service America, Inc.

The Senior Service America, Inc. is a program of the Jefferson County Office of Senior Citizens Services under the supervision of the Jefferson County Commission. It is funded seventy-five percent (75%) by a Title V grant from the Alabama Department of Senior Services with twenty-five percent (25%) local matching funds. The Jefferson County Office of Senior Citizens Services maintains total control and supervisory responsibilities for the Senior Service America, Inc.

The Agency, the Jefferson County Council on Aging, shall provide fiscal administration of the Title V funds to pay salaries, FICA and Workman's Compensation Insurance for the approximately fifty-six (56) older individuals employed by the Senior Service America, Inc. Supportive Services available to Senior Workers including training, physical examination or incidental expenditures shall also be paid using Title V funds.

The administrative funds of Title V should be used for the purpose of reimbursement to ADP for services rendered and for any cost related to payroll. These funds may be used to pay for a percentage of the audit cost for the Agency as outlined in the budget. All expenditures made from the administrative funds must be approved in advance by the Executive Director of the Jefferson County Office of Senior Citizens Services. Exhibit II found in Contract #240-10 shall be submitted monthly to the County along with the SA-1. Supporting documentation of expenses paid from administrative funds shall be made available to the County as requested.

(All other attachments/exhibits not included with agreement)

3. TERMS OF AGREEMENT AND AUTHORIZATION TO PERFORM WORK: The Contractor shall be available to render professional services to the Office at any time after the effective date of this Contract. This contract will be effective July 1, 2010 and will terminate on June 30, 2011. However, contract may be extended, at the County's option. Provided, also, that the County may cancel upon 30 days written notice to the Contractor.

4. COMPENSATION: The Contractor shall be compensated for services as shown on Attachment I of this Contract. The total for the contract to June 30, 2011 is \$936,057.00 of which \$827,577.00 is federal funding with \$108,480.00 being non-federal. The Contractor shall submit to the Office monthly the Employee Individual Report (Exhibit II) for completion for work performed. The Contractor shall submit a quarterly Report of Expenditures and Request for Funds (Exhibit I) unless other arrangements are made with the Office's Accounting Department.

5. INDEPENDENT CONTRACTOR: The Contractor acknowledges and understands that the performance of this contract is as an independent contractor and as such, the Contractor is obligated for all applicable federal, state and local taxes, etc. except for FICA taxes and Worker's Compensation which is part of the budget component shown on Attachment 1.

6. NONDISCRIMINATION POLICY: Both parties agree that all services rendered under this contract will be done without regard to race, creed, color, sex, national origin, or disability.

7. MISCELLANEOUS REQUIREMENTS: Upon execution of this contract, the Contractor shall furnish the Jefferson County Finance Department with information required for Form 1099 reporting and other pertinent data required by law.

8. TERMINATION OF CONTRACT: This contract may be terminated by the County with a thirty (30) day written notice to the other party regardless of reason. Any violation of this agreement shall constitute a breach and default of this agreement. Upon such breach, the County shall have the right to immediately terminate the contract and withhold further payments. Such termination shall not relieve the Contractor of any liability to the County for damages sustained by virtue of a breach by the Contractor.

9.
