11. Update on Clastran Payment

CLASTRAN UPDATE

Sandra Little Brown, Chair

Community Service and Roads and Transportation

ClasTran is designated as the local implementing agency to provide specialized Para Transit transportation service for the elderly and/or disabled or those who otherwise meet the eligibility requirements of the Americans with Disability Act (ADA).

On December 22, 2010 the Jefferson County Commission Finance Department released \$300,000.00 to ClasTran (Birmingham Regional Para Transit Consortium): representing the total amount budgeted as the Commission's local match commitment for ClasTran's fiscal year ending September 30, 2011. Funding for ClasTran was budgeted through the Jefferson County Commission's Office of Senior Citizens Services (OSCS).

The Scope of Services set out in the OSCS contract with ClasTran called for the agency to provide a minimum of 150,000 trips to OSCS Senior Centers (congregate meals sites).

Prior to fiscal year 2010-11, the County Commission had annually provided \$600,000.00 to ClasTran to meet its local match requirement for the draw-down of federal funds as well as to provide trips to OSCS congregate meal sites and other transportation services. This is contrary to some recent media reports that attributed the City of Birmingham as the agency's major funding source. However, according to John Talley, Deputy Director of ClasTran, he could not confirm any other funding from the City of Birmingham prior to that provided funding to ClasTran for fiscal year 2009-10, when Jefferson County had to reduce its commitment to ClasTran to \$300,000.00 due to its severe financial constraints.

Moreover, a letter from ClasTran dated December 28, 2010 and received in my office January 3rd, reflects that although ClasTran had only requested level funding from the City of Birmingham of \$243,000.00, rather than the actual amount of \$334,559.00 based on the percentage of trips

provided to Birmingham residents, the City has only paid \$121,500.00 of the requested amount. Clastran stated in its letter that it still needs the balance of \$121,500.00 from the City of Birmingham in order to continue to provide service at current levels to September 30, 2011.

In this regard my Office has been in communication with Birmingham City Councillor Kim Rafferty, Chair of the City Council's Transportation and Communications Committee and Carole Smitherman, Committee Member, to hopefully secure the balance of funds needed from the City of Birmingham, but also to coordinate the convening of a "summit" of elected officials from Jefferson County cities served by ClasTran and to impress upon them the need to contribute their fair share of costs to keep these valuable services available for their residents.

My office has also been in contact with The League of Women Voters of Greater Birmingham and hope to engage their assistance in convening a region-wide "summit" on public transportation in order to address the need of mobility and access for all citizens to new employment opportunities assisted through the County Commission.

PROPOSAL TO THE JEFFERSON COUNTY COMMISSION

FOR CONSULTING SERVICES TO ASSIST IN THE BUDGET PROCESS

January 3, 2011

Based on discussions with the members of the Jefferson County Commission, and drawing upon its expertise in budgetary analysis and in developing Smart Budgeting methodologies for Jefferson County as well as other governmental units in Alabama, the Public Affairs Research Council of Alabama (PARCA) offers to provide the following consulting services to assist the Commission in developing information that will improve its ability to make sound budgetary

decisions.

Services to be provided:

1. A PARCA staff member will attend and participate in budget hearings for Jefferson County departments during mid-January 2011 to assist County Commissioners in developing information that will improve its ability to make sound budgetary decisions. It is estimated that these hearings will require the availability of PARCH staff for approximately 24 hours over a two-week period.

2. PARCA will respond in a timely manner with data and explanatory memoranda to specific information requests from the County Commission that arise from these budget hearings.

Compensation for services provided:

In return for the services described above, the Jefferson County Commission agrees to compensate the Public Affairs Research Council of Alabama at the rate of \$85.00 per hour for actual time spent in attendance at budget hearings and for estimated time spent in research that responds to information requests from the Commission. Estimates for the time required to answer information requests will be agreed upon by the parties in advance, in order to ensure that the time commitments and expenditures under this agreement can be maintained.

The parties agree to limit expenditures for the services described above to no more than \$4,000.00 unless both parties agree to exceed this cap.
