### MATERIAL EVENT NOTICE

March 30, 2012

The following information is provided by Jefferson County, Alabama (the "County") with regard to its General Obligation Warrants described on Schedule A hereto (the "Warrants"). Although the County has no Continuing Disclosure Agreement with regard to its General Obligation Warrants, Series 2001-B (the "Series 2001-B Warrants") (due to their exemption from the continuing disclosure obligations of SEC Rule 15c2-12), the County has nonetheless determined to include certain information regarding the Series 2001-B Warrants in this Notice in order to provide a more thorough description of the events reflected herein.

## **Scheduled Principal and Interest Payments**

The County filed a petition for relief under Chapter 9 of the United States Bankruptcy Code with the United States Bankruptcy Court for the Northern District of Alabama, Southern Division on November 9, 2011 (*In re: Jefferson County, Alabama*, Case No. 11-05736-9). On March 28, 2012, the County announced that it will not make the principal and interest payments on the Warrants due April 1, 2012. The County expects to suspend payment on the Warrants until debt service on the Warrants can be restructured under the County's Plan of Adjustment under Chapter 9.
