Rating Upgrades

Certain of the Warrants are insured by National Public Finance Guarantee Corporation (formerly MBIA Insurance Corporation) ("National"), as reflected on Schedule A (the "Nationalinsured Warrants"). The National-insured Warrants were assigned insured ratings by Standard & Poor's Ratings Services ("S&P"), Moody's Investors Service, Inc. and Fitch Ratings Ltd.

On May 8, 2013, the insured rating assigned to the National-insured Warrants by S&P was raised to 'BBB' from 'BB' in conjunction with the corresponding upgrade in such rating agency's financial strength and financial enhancement rating of National. The insured rating of the National-insured Warrants was classified as "CreditWatch Positive" by S&P.

On May 10, 2013, the insured rating assigned to the National-insured Warrants by S&P was again raised to 'A' from 'BBB' in conjunction with the corresponding upgrade in such rating agency's financial strength and financial enhancement rating of National. The current insured rating of the National-insured Warrants is classified as "Outlook Stable" by S&P. Ratings reports issued by S&P can be obtained from the S&P website at www.standardandpoors.com.
