WITNESSETH:

WHEREAS, the OWNER is this day accepting responsibility for perpetual care, operation, maintenance, and associated liabilities of the stormwater management facilities installed on that certain real property known as \_\_\_\_\_, as described in the deed and as shown on the plat thereof recorded in the Deed Book \_\_\_\_\_, Page \_\_\_\_\_, Map Book \_\_\_\_\_ Page \_\_\_\_\_ or instrument number \_\_\_\_\_ in the Jefferson County Office of the Judge of Probate; and,

WHEREAS, as part of construction of the development, the COUNTY, Subdivision & Construction Regulations require that a stormwater management facility be constructed; and,

WHEREAS, the OWNER accepts responsibility for maintenance of the stormwater management facility/facilities listed below. Please provide the type of the stormwater water management facility/facilities and the numbers of each on the lines provided.

Operation and maintenance of the stormwater management facilities shall be in accordance with Article 14 of Jefferson County’s Subdivision & Construction Regulations; and,

WHEREAS, the OWNER grants access to the COUNTY to inspect the stormwater management facilities; and,

WHEREAS, the OWNER understands that this Agreement shall inure to the benefit of its successors in title, whomsoever they be in the future.

NOW THEREFORE, it is understood and IT IS AGREED by and between the parties:

1. Maintenance of the stormwater management facilities shall be the sole responsibility of the OWNER.

2. The responsibility for maintenance of the stormwater management facilities shall pass in the chain of title to the OWNER'S successor in interest.
3. Operation and maintenance will be in accordance with Article 14 of the Subdivision & Construction Regulations.
4. Access is granted to the COUNTY to carry out all provisions of the COUNTY'S Subdivision & Construction Regulations, including but not limited to inspections of the stormwater management facilities.
5. The OWNER will at least annually inspect and provide a copy of its inspection report to the COUNTY no later than September 30<sup>th</sup> each year.
6. Any required maintenance or remedial work identified in the report must be completed within sixty (60) days of the inspection.
7. OWNER will submit evidence that the required maintenance or remedial work identified during the inspection have been completed within sixty (60) days of the inspection.
8. Failure to follow the Operations and Maintenance Plan and/or failure to complete necessary repairs identified will result in enforcement action.
